



This contract is between Fall Flight Retrievers and \_\_\_\_\_ (owner) for the purpose of training and having trained the owner's retriever for gun dog, obedience, and/or hunt tests. The following agreement is agreed upon between the two parties.

The Owner agrees to vaccinate or have vaccinated his/her retriever for the following canine diseases before placement at Fall Flight Retrievers for the purpose of training. Owner agrees to provide documentation from a veterinarian. This is mandatory to provide a safe environment for all animals at Fall Flight Retrievers.

**Canine Distemper, Infectious Canine Hepatitis, Canine Parvovirus, Leptospira Canicola, and L. Icterohaemorrhagia and Respiratory Disease caused by Canine Adenovirus Type 2 and Para Influenza, Rabies, and Bordetella Bronchiseptica and Infectious Tracheobronchitis aka "Kennel Cough".**

DISCLAIMER: All payments are due on the first of the month, regardless of the date you drop your dog off for training. If your payment is not received by 11:59pm COB on the first of the month, **you will be charged a late fee for each day that you are past due on your payment.**

**SERVICES PROVIDED:** Fall Flight Retrievers specializes in field obedience and gun dog training. Training is conducted in various natural/wildlife settings. Training is provided by Bill Faulkner, Professional Canine Trainers and Behavior Consultants (any one or more referred to herein as a "Trainer" or "Trainers"). Beyond training services, Fall Flight Retrievers also offers: assistance with finding puppies, started puppies, and started dogs; assistance with championship titling of dogs including instruction, travel to and from events, and participation in events; general, conditioning, and bird exposure, boarding services; and guided wild bird and hunting preserve hunts. Additional services beyond training services and the training options outlined below, shall be billed and charged separately at rates to be established by Fall Flight Retrievers, from time to time.

**PAYMENT:** Payment will be billed monthly with payment due within ten (10) days of the date of such billing or invoice. Any balance remaining will be due upon pick-up of Dog. No refunds will be given unless training is cancelled by Fall Flight Retrievers if any amounts due and payable by client are not paid when due as provided for in this agreement, client shall reimburse to Fall Flight Retrievers, all actual costs of collection, including attorney fees and costs incurred by Fall Flight Retrievers. In collecting amounts due and owing from client under this agreement or for otherwise enforcing the terms of this agreement.

**DANGER:** Client agrees to indemnify and hold Fall Flight Retrievers harmless **from all liability** for any loss, damage, or injury to persons, animals or property arising from or related to Client, the Dog or other animal's activities before, during or after training. Client agrees that Fall Flight Retrievers shall not be liable for loss or damage to the Dog for any reason. Client understands that training is not without risk to Dog, Client, Client's family members, invitees, or guests. The dangers may include, by way of example and not limitation: (a) animals that are difficult to control and that may bite, trip, knock down, collide, or fight; (b) the use of shot guns during the training and/or competition; (c) natural and man made hazards (e.g., wildlife, equipment, slippery surfaces, trip hazards) that may exist on training and/or competition Location; (d) hazards associated with travel to and from training and/or competition Location; and (e) injury or death of the Dog.

### Liability Information

For good and valuable consideration, the parties agree to all of the foregoing terms of this Agreement, and to the following additional terms and conditions:

1. **Training:** Fall Flight Retrievers agrees to provide training of Dog. Private Lessons for Client and Dog will follow training, the goal being to teach Client how to train and work with Dog. These lessons will take place at location stated above. However,

training may take place at various locations in state and out of-state, at Fall Flight Retriever's sole and absolute discretion. Thus, Client acknowledges that travel may occur and that this may pose risk to the Dog.

2. Client's Duty to Assist in and Continue Training: Client understands and agrees that s/he and any family members, guests or invitees must follow Fall Flight Retrievers' instructions and constantly reinforce the training being given to Dog.

3. Client's Assumption of Risk: Client acknowledges that training location, and the animals, guests, items and activities there on, pose dangers to people and animals. Such dangers include, by way of example and not limitation: (a) animals that are difficult to control and that may bite, trip, knock down, collide, or fight; (b) the use of shot guns during the training and/or competition; (c) natural and man-made hazards (e.g., wildlife, equipment, slippery surfaces, or trip hazards) that may exist on training and/or competition Location; (d) hazards associated with travel to and from training and/or competition Location; and (e) injury or death of the Dog. Accordingly, Client, on behalf of him/her, his/her family, guests and invitees, assumes the risk of injuries, losses, damages, costs and expenses by any means above described, and other injuries, losses, damages, costs and expenses of every possible cause and description. If Dog is injured or dies in a dog fight or an accident, gets fleas, ticks or worms, contracts any illness or disease, is lost or stolen, or engages in any dangerous, vicious or unwanted behavior, during or after the term of this Agreement, on or off training Location, Client accepts the risk of the same and agrees that Fall Flight Retrievers shall not be held responsible for it or any resulting injuries, illnesses, losses, damages, costs or expenses whatsoever.

4. Client's Liability: If Client, its family, guests or invitees, or the Dog causes property damage, or bites or injures any dog, animal or person (including but not limited to individuals of Fall Flight Retrievers), during or after the term of this Agreement, on or off Premises, then Client agrees to pay all resulting losses and damages suffered or incurred by Fall Flight Retrievers, and to defend and indemnify Fall Flight Retrievers from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney's fees.

5. Termination: At Fall Flight Retrievers' sole election, Fall Flight Retrievers' duties hereunder shall terminate if (a) in Fall Flight Retrievers' sole judgment Dog is dangerous or vicious to any individual of Fall Flight Retrievers or any other person or animal, or interferes with the training of other dogs; or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Fall Flight Retrievers' duties shall terminate but all other provisions of this Agreement shall continue in full force and effect. No refunds will be given for training under such circumstances. A pro-rated refund determined by Fall Flight Retrievers will be given for unused training time cancelled due to reason (a). No refunds will be given for training terminated due to reason (b). Notwithstanding the foregoing, Fall Flight Retrievers reserves the right to refuse to provide goods and/or services to Client, at any time and from time to time, at its sole discretion.

6. Bad Checks: Any checks returned or not honored will result in the Client's account being restored to the full original sum owed, plus applicable interest. All actual out-of-pocket bank and other administrative charges incurred by Fall Flight Retrievers as a result of such failed payment shall be paid for by the Client and applied to the Client's account. In addition, a \$25.00 charge will be assessed for each returned or dishonored check. Full payment is then immediately due and payable.

7. Veterinary Care: The Client hereby authorizes Fall Flight Retrievers to seek veterinary or other care of the Dog, in a manner and at a location to be selected by Fall Flight Retrievers, in their sole and absolute discretion. Client shall be solely responsible for the cost of any such veterinary care or treatment incurred on behalf of the Dog. Fall Flight Retrievers shall not be liable to the Client for decisions it makes regarding obtaining or not obtaining veterinary care or treatment.

8. Personal Guarantee: If the Client is an LLC, Corporation, LLP or other entity, then the individuals signing this Agreement hereby agree to, jointly and severally as applicable, personally guarantee the payment and collection of all fees and costs payable under this Agreement, on behalf of said entity.

9. NOTWITHSTANDING ANYTHING CONTAINED IN THIS AGREEMENT TO THE CONTRARY, FALL FLIGHT RETRIEVERS. SHALL NOT BE LIABLE TO THE CLIENT FOR ANY DAMAGES INCURRED BY THE CLIENT WHICH ARE SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES, OF ANY KIND OR NATURE, AS A RESULT OF ANY GOODS OR SERVICES PROVIDED TO CLIENT BY FALL FLIGHT RETRIEVERS CLIENT HEREBY EXPRESSLY WAIVES CLIENT'S RIGHTS AGAINST FALL FLIGHT RETRIEVERS FOR SUCH SPECIAL, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES. CLIENT'S SOLE REMEDY SHALL BE FOR THE RECOVERY OF ACTUAL DAMAGES INCURRED AS A RESULT OF GOODS OR SERVICES PROVIDED TO CLIENT BY FALL FLIGHT RETRIEVERS, FROM TIME TO TIME, SUBJECT TO PARAGRAPH 10 BELOW AND THE OTHER TERMS AND RESTRICTIONS OF THIS AGREEMENT.

10. NOTWITHSTANDING ANYTHING CONTAINED IN THIS AGREEMENT TO THE CONTRARY, LIABILITY OF FALL FLIGHT RETRIEVERS. UNDER THIS AGREEMENT TO THE CLIENT FOR ACTUAL DAMAGES IS LIMITED TO AND SHALL NEVER EXCEED THE ACTUAL DOLLAR AMOUNTS PAID BY CLIENT TO FALL FLIGHT RETRIEVERS FOR A PARTICULAR GOOD AND/OR SERVICE CAUSING ACTUAL DAMAGES.

11. New Policies: Fall Flight Retrievers reserves the right to adopt new and additional policies (including pricing policies) and procedures, from time to time, without the prior written permission of the Client.

12. NO WARRANTY: The parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to Dog or anything else. Without limiting the generality of the foregoing, Client acknowledges that Fall Flight Retrievers has not represented, promised, guaranteed or warranted that Dog can be trained, that Dog will never bite, that Dog will not be dangerous or vicious in the future, that Dog will not exhibit other behavioral problems, or that the training will last for any particular amount of time.

13. Expense of feeding dog(s) is included in the training contract prices. Fall Flight Retrievers feeds Inukshuk dog food. Specialized feed required by the client must be provided by the client at their expense. Live birds will be provided by Fall Flight Retrievers at the request of the client, at the client's expense.

14. If the client requests/agrees that the dog(s) participate in Hunt Test events under the handling of Fall Flight Retrievers the following will apply: Client will reimburse monthly all entry fees incurred by Fall Flight Retrievers. **Also, a fee per event handling/transportation fee will apply for each dog.**

15. Fall Flight Retrievers will, on a routine basis, inspect dog(s) for injury or sickness. Proper veterinary care will be sought in the case that it is deemed necessary by Fall Flight Retrievers.

The client authorizes needed veterinary care by signing this contract. Client also agrees to reimburse all medical service and medicine fees. Payment of these fees will be on a monthly basis added to the monthly training fee invoice.

**The client is responsible to have all vaccinations (rabies/booster) shots current on their dog(s). Fall Flight Retrievers also requires that each dog be treated for kennel cough. The client will provide documented proof on or before the time the dog arrives at Fall Flight Retrievers. The client must provide enough heartworm medication and flea/tick medication to last the dogs stay.**

Fall Flight Retrievers will administer these medications on a schedule determined by the client. Fall Flight Retrievers can provide such medications at the expense of the client, and will be added to the monthly invoice.

16. In the event client fails to pay fees and/or expenses outlined by this document for a period of 90 days, ownership of contracted dog will be forfeited. After notification that the contract has reached the 90 day delinquent status, client will forfeit contracted dog to cover outstanding balance due to Fall Flight Retrievers. Also, the client will be obligated by this contract to transfer all ownership documentation and registration to Fall Flight Retrievers. If legal action is required to obtain proper ownership documentation, client will be bound by this contract to pay attorney's fees and court costs incurred by Fall Flight Retrievers to obtain ownership transfer.

17. Training fees will be billed once per month and due on the 1st of every month. The Owner agrees to pay these fees by the 1st of the month. First month's fee is due when your dog is dropped off at Fall Flight Retrievers to begin its training program. The Owner agrees and understands that the training fees are on a "per month" basis. The Owner understands that this means that while the Owner's dog is in training, the owner will be billed for the entire month regardless if the dog is taken home for periods of time for whatever reason. If the Owner wishes to remove his/her dog from Fall Flight Retrievers, the removal must be done prior to the 1st of the Month. If the dog is not removed before the 1st of the month, the Owner understands he/she will be billed for a full month of training.

CLIENT HAS READ, UNDERSTANDS, AND AGREES TO ALL TERMS AND CONDITIONS SET FORTH IN THIS AGREEMENT.
